All wedding bookings require a \$50 retainer payment & signed contract to be secured.

Dates are not held by inquiries. The retainer is applied to your day-of service.

Applies to the following observed holiday weekends (Friday- Monday) Memorial Day, Independence Day, and Labor Day. Weddings are **not** scheduled on Thanksgiving, Christmas, and New Years Weekends

# YOU HAVE QUESTIONS

---

Q: Do you take separate payments from each person?

A: I only take payment from you! If someone is financially helping out or if your wedding party is paying for their own services, please have them pay you privately!

Q: What's required to book? And how quickly should I book?

A: When you're ready to go forward, you'll receive a proposal of services, which includes an itemized invoice, payment schedule, and contract. A \$50 retainer payment and signed contract are what's required to secure your date. Most of my clients book within 12-18 months of their big day. The longer you wait to book, the quicker someone takes the date, as anyone is open to book a date if the contract + retainer payment are not completed.

Q: What is the cost of per person?

A: Please refer to the **Investment Guide** section in the Pricing + Info Guide provided above for bridesmaids/mom/etc. pricing.

Q: How much is a bridal trial?

A: A bridal trial appointment is \$125.

Q: Can anyone besides me book a preview?

A: Anyone who is receiving services is welcome to schedule a preview! It's priced at the same rate as their day-of application. Itemized pricing can be found on the **Investment Guide** page.

# I HAVE ANSWERS

---

**I do not provide air bush makeup or hair services!**

Q: Do you apply lashes? Does everyone get them?

A: Yes and yes!

Q: What brands do you carry?

A: I carry familiar brands such as Nars, Mac, Fenty Beauty, Too Faced, and Danessa Myricks along with professionally recognized products such as Ben Nye and RCMA!

Q: Can we get ready at my venues bridal suite?

A: Please reach out to your venue to see when they open their bridal suite! Some don't open them until late morning/early afternoon which does not give hair and makeup enough time to complete services. I always recommend getting ready at an AirBnB, residence, or hotel suite if this is the case!

Q: Do we need to bring any of our own products or brushes?

A:NO! Down to the single paper towel, I bring everything I need to do the job!

Q: Do you provide touch ups before you leave?

A: Yes! I provide touch up kits for you as well for shine and lips.

# WHAT TO EXPECT

---

## PAYMENTS

If you're ready to go forward, a \$50 retainer deposit is due when booking 2 or more wedding makeup services alongside with a signed contract! The deposit goes toward your total balance of services.

## TRIAL

It is recommended to schedule your trial 3 months out from your wedding date. If you are choosing to be spray tanned for your wedding day, please wear the tan to your trial as well.

## TIMELINE

In my past experience I find everything goes smooth without a planned timeline. I ask that all people who are receiving makeup services be at the assigned getting ready location at the agreed start time.

## Wardrobe

Wear something that makes you feel comfortable & confident! Patterns, bold colors, and accessories photograph really well. Don't hesitate to ask for outfit recommendations. I love getting to help with outfit inspiration!

The ball is in your court to let me know what you're thinkin' and if you'd like to go forward once you receive my email, but I typically reach out a week after this email is sent to give you enough time to discuss any details if needed! Please note that I work on a first-come-first-serve basis, so if I don't hear from you after I follow up, I will move onto the next inquiry for your date.

At any point after you get my email that you let me know you'd like to go forward (if I'm still available), I'll send you the proposal of services which includes an itemized invoice, payment schedule, and contract! A signed contract + paid retainer within 7 days of receiving is required
